### **Terms of Service**

- 1. General
- 1.1 www.gotournamental.com is operated by Go Tournamental Limited ("We" "Us" "Our") . We are registered in England and Wales under company number 9301257 and have Our registered office at Go Tournamental Ltd, 1 Pellings Farm Close, Crowborough, East Sussex, TN6 2BF.
- 1.2 This document (together with any documents referred to in it) tells you the terms of service ("Terms") which apply to Our website www.gotournamnetal.com, which provides a sports tournament planning service. The Terms apply whether you are a guest or a registered user. By using Our Website, you indicate that you accept these Terms and that you agree to abide by them. If you do not agree to these terms of use, please refrain from using the Service. We reserve the right to update and change the Terms from time to time without notice or acceptance by you.
- 2. Free BETA Trial
- 2.1 By subscribing to the Free Beta Trial you are not committing to any payment for the service during your trial period.
- 2.2 As a Trial user, you agree to: Test and evaluate the Service provided to you to ensure it will meet with your needs and requirements. Inform Us of any bugs or other defects you may encounter in connection with the Service. Comply with any reasonable requests and instructions from Us in connection with the Trial, which may be provided from time to time during the Trial Provide Us with your comments, evaluations, suggestions, and recommendations regarding the Trial("Feedback"), all as voluntarily provided by you or as may otherwise be requested by Us. All Feedback that you provide or make available to Us during a Trial, however communicated by you and whether at Our request or not, shall be the sole and exclusive property of GoTournamental from that point onwards, and you hereby irrevocably assign to Us all of your rights, title and interest in and to such Feedback, including, without limitation, any and ALL intellectual property (IP) rights in or to any such Feedback.
- 3. Description Of Service
- 3.1 The Service is web-based and allows users that register for an account on the Service (each an "Account Holder") to create, update and run a sports Tournament via the internet. Unless explicitly stated otherwise, any new features that augment or enhance the current Service, including the release of new GoTournamental tools and resources, shall be subject to these Terms.
- 3.2 In order to use the Service, you must arrange for access to the Internet and provide all equipment necessary to make such connection. Our Service may include certain communications from Us, such as service announcements, administrative messages, which are considered part of GoTournamental membership, although you will be able to opt out of receiving them. You agree not to access the Service by any means other than through the interfaces that are provided by GoTournamental for use in accessing the Service.
- 3.3 Within the Service We have provided You with the ability to download a spreadsheet copy of your Tournament fixtures to your personal computer and you acknowledge that it is your sole responsibility to take a copy of your fixtures to be used on the event day should the service be not available or if the software contains a fault or a bug that stops you being able to use the Service. If you have previously relied on using printed materials to display Fixtures and Results on the event day, we strongly suggest you make arrangements, at your cost, for these to be available to you on the day in the event that the Service is not available to you.

- 4. Registration
- 4.1 Users under 13 years of age may access the Website but cannot be an Account Holder or create a GoTournamental ID.
- 4.2 In order to use the Service, you must have a valid GoTournamental account. To be an Account Holder with Administrator capabilities, you must accept these terms and conditions and provide GoTournamental with a valid email address and other information ("Registration Data"). As an Account Holder, you will choose a password to enable you to have access to the service. You are responsible for maintaining the confidentiality of the password and account, and are fully responsible for all activities that occur under your password or account.
- 4.3 You agree to immediately notify Us in writing of any unauthorised use of your password or account or any other breach of security and you must ensure that you exit from your account at the end of each session. We will not be liable for any loss or damage arising from your failure to comply with this clause 4.3.
- 4.4 You agree to provide true, accurate, current and complete information about yourself as prompted by the Service's registration form, and you must maintain and promptly update the Registration Data to keep it true, accurate, current and complete. If you provide any information that is untrue, inaccurate, not current or incomplete, or We have reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, We has the right to suspend or terminate your account and refuse any and all current or future use of the Service (or any part thereof).

### 5. Charges and Payment

# 6. Cancellation and Termination

- 6.1 If you cancel the Service, your cancellation will take effect immediately. After cancellation, you will no longer have access to your Tournament and all information contained therein may be deleted. We accept no liability for such deleted information or content.
- 6.2 We may, in our sole discretion, terminate your password, and/or account, and remove and discard any Content within the Service, for any reason, including and without limitation, the lack of use, or if We believe that you have violated or acted inconsistently the Terms. We may also, in our sole discretion and at any time, discontinue providing the Service, or any part thereof, with or without notice.
- 6.3 You agree that any termination of your access to the Service under these Terms may be effected without prior notice. We reserve the right to bar any further access to the Service or data contained therein. We will not be liable to you or any third-party for any termination of your access to the Service.

## 7. Privacy

We may collect your data when you use the Website. For further information please refer to our cookie policy and privacy policy.

- 8. Content And Conduct Rules And Obligations
- 8.1 You understand that all information, data, text, software, images, photographs, graphics or other materials ("**Content**") are the sole responsibility of You the Account holder from where such Content originated.
